

# **1.1 Event Overview**

The 2018 WSM Performance Parts Australian National Watercross Titles will attract Australia's best PWC racers to the shores of Lake Macquarie, NSW. This event will cater for both Endurance and Circuit racing, across a range of classes including allocation of the top 10 riders in both Pro GP Runabout and Pro Modified Ski.

# **1.2 Event Host**

The Sydney Jet Sports Association, Trading As, New South Wales Personal Watercraft Club (NSWPWC) is a NSW based non for profit association that is responsible for the safe promotion of PWC racing within NSW. The NSWPWC is an affiliate of the Australian Jet Sports Boating Association (AJSBA), which is the Australian representative body for all Personal Watercraft Racing.

NSWPWC's regular events are held at the St George Sailing Boat Club at Sans Souci in Sydney's south. In addition to this, the association occasionally holds other events in various locations throughout NSW including Lake Macquarie, Newcastle, Albury and Mudgee.

This event will be hosted by NSWPWC, on behalf of the AJSBA in their home state.

# 2. Conditions of Entry







# 2.1 Key Conditions

The following key conditions are to be meet at all times during the event:

- Entrants are to deliver their PWC and trailer to the event compound from 630am.
- NO PWC'S ARE TO BE STARTED PRIOR TO 8am (in or out of the water).
- Cars are to be immediately removed from the PWC area and parked in the nominated car parking areas or removed from site. **NO CAR or TRAILER PARKING ON GRASSED AREA.**
- All rider meetings are compulsory attendance for riders. Riders that are late or not attending the meeting will be given a penalty start or disqualified from the event.
- Riders may be tested for the presence of Drugs or Alcohol. Any rider found to be under the influence of either substance will be removed from the event immediately.
- Safety scrutineering will take place in the event carpark prior to the event on Friday 8<sup>th</sup> June. This will be the only time available to have your boat scrutineered. There will be a 30 minute timeslot for scrutineering on Saturday morning before the event. These spots will require a booking however as they are limited and will only be confirmed by emailing <u>operations@nswpwc.org.au</u> and a response is received.
- No PWC is to enter the water without being passed through scrutineering.
- All riders must wear Approved Safety equipment including:
  - Approved full face motorcycle helmet motocross style (not downhill mtb bike helmet)
  - an approved PFD
  - hard shell Back Protection to the specifications of IJSBA rule 17.3.4
  - long leg wetsuit and enclosed footwear
- All holders and teams will need to sign a waiver form and receive a wristband.
- No refuelling is allowed in any area, except the refuelling bay. Jerry Cans can be stored in the designated fuel storage container at a cost of \$5. All Fuel cans must be marked with an approved tag, which will be issued with your entry pack. Fuel cans can removed from the fuel storage container during the event and taken to be refilled (off site at a service station) and then returned.

Non-compliance with these requirements or clear directions from race officials may result in disqualification and removal of your PWC, support staff and riders from the event without refund of entry fees.

# **2.2 MEDICAL CONDITION OR INJURY**

If any rider has any an existing medical condition, they should provide this information including any specific medication details attached to their entry form. This will enable emergency services to respond accordingly in the case of an incident.

In addition to this, the AJSBA reserves the right to demand that a rider that has or is suspected of having a medical condition (injury, or previous significant injury) obtain and provide a current (within 2 weeks of the event) medical certificate outlining that:

• The rider is physically fit and capable of managing their PWC in a racing situation without risk that the medical condition may cause loss of control of the PWC and place other racers, riders or officials associated with the event in danger.







# **2.3 DECLARATION AND INDEMNITY**

By completing and signing the entry form you confirm that you have read and understand the following:

- 1. I the signer, in consideration or as a condition of acceptance of my entry in the above event for myself, my heirs, executors, administrators, hereby waive all and any claim rights or course of action which I or they might otherwise have for or rising out of the loss of my life or injury, damage or loss of any description whatsoever which I may suffer in the course of or consequent entry of participation in the said event.
- 2. This waiver release and discharge shall be and operate separately in favour of all persons, corporations and bodies involved or otherwise engaged in promoting or staging the said event and the servants, agents, representatives and officers or any of them and includes but is not limited to the volunteers, committee or officials of either the Australian Jet Sports Boating Association, the Sydney Jet Sports Boating Association trading as New South Wales Personal Watercraft (affiliate host club) or the organisers of the event, medical and paramedical practitioners and personnel, police officers, shire councils and shall operate whether or not the loss, injury or damage is attributed to the act or neglect of one or more of them.
- 3. I hereby indemnify the committee, the affiliate host club, event organisers, the members and the Australian Jet Sports Boating Association, and the event volunteers against all suits, claims and demands whatsoever arising out of my participation in the said event.
- 4. I declare that I will abide by the competition rules and will accept the organiser's decision as final.
- 5. I acknowledge that this declaration and indemnity applies to the participation of the signer in the said event.
- 6. I have read and understand all competition rules, entry information details as well as supplementary regulations both general and specific to this event.
- 7. I acknowledge that I have read and declare that I will abide by the AJSBA Code of Conduct.
- 8. I solemnly swear that I hold a current PWC licence.
- 9. I confirm that all the information I have provided is true and correct.
- 10. I allow for the use of all images and video captured during the event to be used by the event organisers, authorities, agencies for reasonable promotional and marketing material.
- 11. The Event Manager has approval to place / secure (causing no damage) a small portable camera on any PWC entered in the event for the purpose of capturing event footage.

# 2.4 AJSBA Code of Conduct

In entering this event, each rider and team agree to act in accordance with the AJSBA Code of Conduct. A copy of this code can be located at <u>www.ajsba.org.au</u>

# 2.5 Drug and Alcohol Testing

On entering this event the rider agrees to undertake a drug and / or alcohol tests at any point in time during the event by either event staff or the NSW Police. Should a rider be found to be under the influence of either substance, they will be removed from the event immediately (without refund).







# 2.6 Protected Sea Grass Area

The foreshores of Lake Macquarie contain delicate sea grass habitats. For this reason, NO PWC is to enter the designated area's outside of the official race site. The following map outlines the relevant sea grass areas.

# **2.7 PWC Event Specific Restrictions**

- No PWC engines are to be started before 8am or after 6pm in or around the event site.
- No PWC's are to be washed out on the race site.
- All hazardous materials are to be removed from site and disposed of at an approved hazardous materials site (fuel, oil etc).



# 3. Site & Track Layouts







# **3.1 Event Location**

The Event will be located in Lake Macquarie NSW Australia, which is 1 hour and 45 min north of Sydney, and 15 minutes south of Newcastle NSW.

- Racing will staged from Warners Bay Park located at 1 Bareki Road, Eleebana NSW, Australia.








# 3.2 Site Layout

- The eastern side of the car park will be utilised for competitors vehicle parking (no trailers).
- The western side of the car park will be utilised for trailer parking, emergency and official vehicle parking.
- No trailers, car's or PWC's are to be parked in the trailer / boat manoeuvring area.
- The fuel storage container and refuelling bay are to be located in a designated eastern car park area.
  - $\circ$   $\;$  All fuel is to be registered and stored in the area.
  - All refuelling is to occur in the refuelling bay.
  - Under no circumstances is Fuel or Oil to be used outside of the designated area.
- All competitor pit tents are to be installed in designated areas.
- PWC's are not to be ridden under power onto the bank or the shore.










# 3.3 Endurance Track

- The race will start with a standing start. Separate start lines for:
  - o Pro GP
  - o Pro / Amateur
  - o 1100 Runabout (in a separate moto to the other runabout classes)
- Under no circumstances is a rider to turn back or attempt to renegotiate a missed Buoy.
- Touching or hitting a Buoy within the endurance race is counted as a 'Missed Buoy'.
- A 'Missed Buoy' marker will be nominated. This has to be taken on the following lap to negate having a lap deducted.
- Races will be approximately
  - GP & Pro / Am Runabout 25 min + 1 lap.
  - 1100 Runabout 20min + 1 lap
  - Each lap is approximately 4-4.5km.
- Up to 3 moto's per event.
- There is no cross entering in the Endurance format (from Stock Runabout to GP Runabout).









# 3.4 Circuit Track

- Some races may have 2 separate classes in the race. If this is the case, then:
  - Each class may start from a nominated side of the grid (inside or outside).
  - Each class will be scored separately.
- The race will start with a 2 1 board and release of the band.
  - 2 start your engines and confirm ready.
  - 1 prepare to race.
  - Release Band race commences.
- Riders caught false starting, or not holding their line will be penalised with a dead engine start. Should additional riders be penalised, all penalised riders will have a dead engine start until the moto is successfully started.
- From the start, riders must stay within their nominated course for the opening lap.
- Once the finish line is crossed for the first time, riders can elect which split they utilise (green or blue). This must occur at the 'decision buoy' (white/grey) on plan.
- Under no circumstances is a rider to turn back or attempt to renegotiate a missed Buoy.
- A 'Missed Buoy' marker will be advised to riders. This may be taken on the following lap to negate having a lap deducted.
- Runabout and Recreational Classes
  - Will negotiate the entire track including the 2 north-eastern red buoys.
  - Will NOT utilise the log jump.
  - Races will vary from 7-11 min + 1 lap. Each lap is approximately 2.0km.
- Ski Classes
  - Will negotiate the shorter track which excludes the 2 north-eastern red buoys.
  - Ski riders (NOT Juniors) must use the log jump (Blue Z marker) from the second lap of the race (unless closed by an official for safety reasons).
  - Races will vary from 7-11 min + 1 lap. Each lap is approximately 1.8km.
- The event will contain up to 4 moto's.









# 4. Rider Requirements







# 4.1 Licensing

Each rider is required to hold a current PWC License and Current AJSBA Race license. Only National Licenses can be used at this event (no day licenses). International riders are required to hold an affiliate IJSBA club / association license.

# 4.1.1 Competitor & Support Crew Uniforms

It is recommended (especially for pro class license holders) that each competitor and their support crew, handlers, mechanics etc consider the use of team uniforms. The use of consistent and labelled clothing enables the officials, public and supporters to clearly identify each of the teams.

In addition to the above it enhances the appearance and professionalism of our sport.

### 4.1.2 Junior riders

Riders under the age of 16 years must obtain an AJSBA junior race license and complete all of the required testing / training / assessment process before being able to race at an event. Junior riders cannot race on a day license.

Junior riders will not race in the same race as seniors, and must only ride Lites Class Ski's.

### **4.2 Rider Equipment**

The following items will be checked at the pre event scrutineering, and must be **worn at ALL times** when on the water (including moving or testing a PWC):

- Approved full face motorcycle helmet motocross style (not downhill mtb bike helmet)
- an approved PFD
- goggles
- hard shell Back Protection to the specifications of IJSBA rule 17.3.4
- a full leg wetsuit and enclosed footwear

It is also recommended that you wear the following:

- gloves (motocross or mountain bike style)
- leg guards (for runabout or sport classes)

A detailed list of scrutineering requirements can be found on the AJSBA scrutineering form.







# 4.2.1 Rookie / Beginner Riders

Rookie or beginner riders are not eligible to participate at a National Title event. A rookie rider is someone whom this is their first race event.

### **4.3 PWC Requirements**

### 4.3.1 Scrutineering & Safety Requirements

Safety scrutineering will take place in the event carpark prior to the event. All PWC's are to be checked in accordance with the scrutineering form which includes the following:

- The lanyard is in perfect working order.
- The hull has no protruding items and all parts are secured safely.
- A flexible bow loop is secured to the front of the PWC.
- All engine clamps and hoses are secured, and the battery is fixed in place.
- Engine is sealed and marked.

Safety scrutineering does not consider if the PWC is suitable for the entered class.


NO PWC is to enter the water without being passed through scrutineering.

### 4.3.2 Race Numbers

Every PWC is to have the **nominated race number** affixed to both sides of the PWC in the required location. The race numbers are too clearly legible from a distance.

- Race numbers 1 -10 are only to be used by the nominated top 10 riders from 2017.
- Recommended to be on a White background with 200mm Black block numbers.





# 4.4 Support Staff / Crew / Handlers

It is highly recommended that all riders attend the event with at least 2 support crew / holders that are willing to be involved (including getting wet).

• Runabout / Recreation Classes – Require 2 holders on the start line for each circuit race and 1 holder for each endurance race.







• Ski Classes – Requires 1 holder for each circuit race.


In addition to this holders and crew will be able to assist in getting the rider and PWC to the staging area before a race, moving the PWC in and out of the water between races, and refuelling the PWC.

All support crew, staff and handlers will need to sign an AJSBA waiver form and receive a wristband at the registration desk.

### **4.5 Other Recommended Items**

Competitors are also recommended to have the following items on hand:

- Whatever tools and spare parts may be needed to repair your PWC throughout the event.
- A beach stand or workshop stand that can be used to put your PWC on either in the water or on the shore.
- A tote or trolley to assist in moving your PWC in and out of the water during the event, as trailers will be difficult to access.

# 5.1 Race Entry Process

*Note: Entries received after this date will be charged a late entry fee of \$600 in addition to the regular class entry fee.* 

# 5.2 Event Fee's

The following event fees will be applicable:

Premier Class	\$200
Pro & Am Classes	\$170
Juniors	\$5

Any extra class in the same format (Circuit & Endurance are not the same format) entry by the same rider will be offered a \$50 discount.

All classes require a minimum of 10 entries for the class to be run (or as determined by the AJSBA), except Juniors who require 5 entrants for the class to be offered. The AJSBA reserves the right to merge, remove, combine or upgrade entries should the qty of entries not be reached.

# 5.2.1 Fuel Storage Fees

A fuel storage fee of \$5 per 20L container will be charged to cover the infrastructure costs associated with the fuel container and refilling bays. All fuel within the event is to be stored within the designated area.

All stored fuel containers must be paid for and tagged with an official AJSBA tag. No other fuel containers will be permitted to be kept in the area.

All riders are required to attend the compulsory riders briefings at the following times and locations:

- Friday 8 June 7pm at Warners at The Bay Pre Race Briefing
- Sat 9 June 8.30am at the race site Safety Briefing
- Sun 10 June 8.30am at the race site Safety Briefing

A role call will be undertaken at these meetings. Any rider not attending or paying attention during any of the riders meetings may be penalised or disqualified at the race directors discretion.

The AJSBA strongly advises all competitors familiarise themselves with all aspects of the rulebook for this event and the level of PWC modifications prior to class entry.

Remember all PWCs must be completely standard as per manufacture specifications unless where the IJSBA rulebook allows for changes to be made. If the rulebook doesn't say you can change it, then you can't.

#### 6.3.1 Pre-Race Technical Inspection

**On Friday 8<sup>th</sup> June**, the Pre-Race Technical Inspection will be held for all competitors at the race site. Technical Inspection will be open **between 9am and 1pm ONLY**. The AJSBA strongly encourages entrants to arrive for inspection as early as possible to ensure a pass in the inspection prior to practice.

If for any reason you cannot make this inspection time, or your PWC/Riding gear cannot be present, you must send a request to **<u>operations@nswpwc.org.au</u>** at least 1 week prior to the event for a timeslot on Saturday morning. These spots are limited and not guaranteed until a response is received.

#### *Note: All PWC's and race gear, including spares and backups must be presented for inspection. Failure to do so will result in this equipment not being allowed to participate.*

If any of the official AJSBA seals need to be broken or removed for any reason then approval must be granted from the technical director prior to the seal being removed, during this time the removed part must be handed to the technical director for inspection. Failure to do this may result in instant disqualification from the event.







No PWC will be allowed on the water prior to tech inspection and no PWC will be allowed on the water prior to 2pm practice. There is an alternative local boat ramp for testing purposes away from the race site.

# 6.3.2 Post Race Technical Inspection

After your last race has been completed you and your PWC must return to shore in a designated tech holding area where your PWC will stay until you are either allowed to leave or are required to transport your PWC to the tech inspection tent. These areas will be pointed out in detail at the riders briefing. Under no circumstances are a rider/mechanic or support crew to remove a seat/hood or open a storage compartment when in this area unless directed to do so by a AJSBA official.

Upon entering the tech inspection tent only the rider and one designated mechanic will be able to stay with your PWC and supply the parts required to the technical director for inspection. Each rider will need to supply his/her own basic tools and mechanic to complete the required tasks.

Failure to comply with the IJSBA rulebook or follow the directions given by any AJSBA official may result in instant disqualification from the event.

# 6.4 Race Numbers

We recommend that you check your PWC before the event. If in doubt, please contact the event director. If you do not have an Approved AJSBA race number, then a number will be issued to you before the event. It is your responsibility to have this displayed on your PWC for the event.

If your number is not clear, it will not be scored during the event.

### 6.5 On Track Information

### 6.5.1 Race Track Navigation

Navigation of the track Buoys includes:

- Red Keep to your Left
- Yellow Keep to your Right
- Missed Buoy Colour to TBA
- Split Decision Buoy Colour TBA

### 6.5.2 Race Flags

- White Last Lap
- Checkered Race Finished
- Yellow Caution, rider down
- Blue You are being lapped, please allow them to pass clearly.
- Red Race is immediately over, slow down with caution and return to race site
- Black (Pointed at You) cautiously exit the track and return to shore and see the race director immediately.







# 6.6 Refuelling

All fuel during the event is to be stored within a designated fuel storage container (day by day, not overnight). Competitors are to advice of the quantity of fuel that they require (number of 20L Jugs) on their entry form.

Fuel Jugs are to be officially labelled when they arrive on site in scrutineering and placed in the storage container.

The refuelling area will include the following:

#### Fuel Storage

- All bulk quantities of fuel for the event will be store on a daily basis (not overnight) in a dangerous good storage container.
- Fuel will only be removed for refuelling purposes in small quantities (3 x 20L jerry cans at a time).

#### **Refuelling Bay**

- A designated refuelling bay area will be set up in the car park area. The bay will be para webbed off to restrict access to officials, riders and crew only.
- The bay will have plastic lining with raised hobs on 3 sides (with the open side being raised in level to allow access) to create a catchment area capable of holding the max qty of fuel to be in the bay at any single point in time.
- Only 3 PWC's will be allowed in the bay to refuel at any single time.
- No Smoking within the Event site, pits or car park / refuelling bay area at any times.
- No other mechanical works are to be undertaken whilst refuelling.
- Fuel will be removed from the storage container (3-5m away from the refuelling bay) and placed into the PWC's.
- There will also be a fuel spill kit & 2 x fire extinguishers in the refuelling bay at all times.

### 6.6.1 Refuel Procedure

- PWC is to be removed from the water (tote, trolley or trailer).
- PWC is wheeled into the refuelling bay (no more than 3 PWC's at any one time)
- Obtain the fuel from the storage container.
- Fill the PWC, whilst only opening 1 Fuel Jug at any one time per PWC.
- Place the empty fuel jugs back in the container
- Remove the PWC from the refuelling bay.

# COMPETITION RIDER CLASSIFICATIONS

The Australian Jet Sports Boating Association does not test the skill of adult participants in AJSBA-sanctioned events, nor does the

Association judge each competitor's competence. Participants are solely responsible for their safety.

#### <u>Beginner</u>

A beginner Level competitor has raced less than a season from between one to five times in closed course events

- The Beginner class is provided as an entry-level class for new riders who wish to experience the fun of racing.
  - Beginner-class competitors may race Stock or Limited watercraft only.

#### <u>Novice</u>

Novice competitors are those with minimal racing experience less than 2 seasons. First-time competitors must participate in the Novice or Beginner class.

- NOVICES MAY NOT COMPETE IN OPEN/MODIFIED/GP CLASSES WHERE SUPERCHARGED OR TURBOCHARGED RUNABOUTS AREALLOWED.
- Novice-class riders may be reclassified as Expert-class riders at the discretion of the IJSBA or IJSBA International Affiliate.

#### <u>Expert</u>

An Expert level competitor has raced at least three times in closed course racing during the past season on the same type of watercraft {Ski or Runabout} and has not won more than 2 championships in the last 2 years.

- Expert-class riders are those who demonstrate a skill level that has exceeded beyond that of a Novice-class
  rider. An Expert competitor may request to be reclassified as a Pro by submitting a Change of Classification
  Form to the IJSBA or IJSBA International Affiliate. The IJSBA and IJSBA International Affiliates have the
  authority to move an Expert competitor to Pro if he/she displays skills that are superior to others in that class.
- An Expert competitor may request to be reclassified as a Novice by submitting a Change of Classification to the IJSBA or IJSBA International Affiliate.
- An Expert competitor may be moved back to Novice if it is determined by the IJSBA or IJSBA International Affiliate that his/her riding skill is not Expert-class level.

#### **Professional**

A Pro level competitor has raced at least three times in closed course during the past season on the same type of watercraft {Ski or runabout} and has won 2 or more closed course championship titles in the past. Entry at this level is at the discretion of the AJSBA

- Pro riders are those who have substantial racing experience and have advanced competition skills.
- A Pro competitor may request to be reclassified as an Expert by submitting a Change of Classification Form to the IJSBA or IJSBA International Affiliate.
- A Pro rider may be moved back to Expert if it is determined by the IJSBA or IJSBA International Affiliate that his/her riding skill is not Pro-class level.

#### EVERYONE

- Treat all participants in your sport, as you would like to be treated yourself.
- Control your temper; verbal abuse, threats and physical violence are not acceptable behaviors.
- Respect the rights, dignity and worth of all participants, regardless of their ability, gender or cultural background.
- Be a good role model; be safe, responsible and set a good example outside of organized racing events, especially when on the water.
- Act within the rules of the sport at all times.

- Adhere to Australian Jet Sports Boating Association Pit Rules and Regulations and the Australian Jet Sports Boating Association Drug and Alcohol Policy.
- Respect the waterways operators by adhering to the rules and guidelines of each waterway.
- Be environment conscious; keep your area clean and treat spills appropriately. Leave your area, as you would like to find it.
- All affiliates agree to abide by state laws and ensure that only registered watercraft will be driven/ridden on the waterways by licensed enthusiasts where required by law.

#### OFFICIALS

- Be impartial, consistent and objective at all times.
- Place the safety and welfare of all participants above all else.
- Ensure the spirit of competition is maintained.
- Be understanding and co-operative in the interpretation and application of rules and penalties.
- Condemn unsporting behavior and promote respect for all competitors.

#### PARENTS

- Encourage children to participate to the best of their ability.
- Focus upon the child's performance rather than the overall outcome of the event.
- Teach children that an honest effort is as important as victory.
- Encourage your children to follow the rules and respect the work and decisions of officials and marshals.
- Remember that children are involved in racing for their enjoyment not yours.
- Set a good example by avoiding the use of derogatory or abusive language, respect officials and marshals and never ridicule or scold a child for making a mistake during competition.
- Don't be an ugly parent. If you see 'ugly parent syndrome' behavior, visit <u>www.playbytherules.net.au</u> and help to solve the problem.

#### COMPETITORS

- Your Race Safe Behavior and Attitude will significantly reduce the risks of any Incidents.
- Competitors have the right to Race hard and fast but this must be with the utmost safety and care for your fellow competitors.
- You will wear a Hi Visibility Vest as a beginner Racer or if you have not raced for an extended period.
- You will not attempt the Holeshot as a beginner racer or racing a new class until deemed competent by Race Director, new racers to start on outside grid positions.
- Know your crafts handling under race conditions and ride within your abilities, losing control of your craft has unacceptable risks and consequences to yourself and other riders.
- Passing: riders must always be prepared for another rider to pass and must therefore be aware of other riders approaching from behind. The overtaking rider must consider the safest route to pass and must do so without forcing the overtaken rider to suddenly alter course.
- "Holding your Race Line" under closed course racing conditions is extremely important; when being lapped you need to be able to let faster riders through safely. Lapped slower riders are not permitted to race the front runners.
- New riders or experienced riders are not allowed to race competitors to a buoy if the proximity endangers either rider and there is a possibility of a collision.
- When slowing down or coming off throttle, there are no brake lights on a PWC, raise your left hand when coming off throttle.
- Memorizing a Buoy Course is of paramount importance. Sighting Laps are not a race, they are for memorizing course. After practice and sighting laps make sure you have committed the course to memory if not ask your Race Director for extra Sighting / Practice laps.
- Always compete within the rules.
- Always compete to the best of your ability with honor and integrity.
- Treat Competitors as you would like to be treated, do not interfere with, bully or take advantage of any other participant.
- Avoid the use of course and derogatory language, control your temper Avoid Arguing with Marshals and officials any verbal abuse is unacceptable.
- Be a good sport and applaud good performance, compliment and encourage all participants, Positive comments are motivational, the better the competition the better you will become.
- Competitors are responsible for their own conduct plus there race team.
- Compete within your skill level. Only try and extend these skills when there is no likelihood of danger to yourself and others.
- Recognize the importance of Volunteers that give their time so you can enjoy your sport.
- Place the Safety and welfare of other participants above all else.

#### AUSTRALIAN JET SPORTS BOATING ASSOCIATION DISCIPLINE AND TRIBUNALS

Australian Jet Sports Boating Association expects all Licence holders to uphold the Australian Jet Sports Boating Association Code of Conduct and as such treats allegations of poor conduct and bringing the sport of watercraft into disrepute very seriously. To learn more about Australian Jet Sports Boating Association's disciplinary process and tribunals, contact Australian Jet Sports Boating Association Head Office on admin@ajsba.org.au.

- 1. The AJSBA committee may suspend a rider's membership/licence for breaches of this code.
- 2. The race director has the authority to discipline riders, owners, rider's sponsors and/or pit crew for violation of the IJSBA/AJSBA rules. This discipline may involve disqualification, exclusion from an event and/or ejection from the race site.
- 3. The race director may disqualify, exclude or eject the rider, owners, sponsors or pit crew for any of the following violations: --
  - a. Vulgarity, offensive language or unsportsmanlike actions directed towards officials, spectators or other participants;
    - b. Failure to abide by the IJSBA/AJSBA race rules;
    - c. Failure to comply with watercraft requirements or pit crew non -compliance with regulations;
    - d. Use of intoxicating beverages and/or drugs;
    - e. Unwillingness to accept an official's decision or verbal or physical abuse of any official;
    - f. Participation in an event without holding a valid membership/licence; and
    - g. Providing inaccurate or false information to any officials or any official document.

# ANNEXURE 2: AJSBA PUBLIC LIABILITY COVER

#### AJSBA LIABILITY INSURANCE COVER FOR AJSBA RACING & CLUB ACTIVITIES

#### A BRIEF DESCRIPTION

An Insurance fee is collected by the AJSBA for each event that you enter. This insurance is to protect you, your club and the AJSBA for the following:

#### SCOPE OF COVER

In the event that you, your club or the AJSBA is found liable for injury to members of the public or damage to their property, the policy will cover up to \$20,000,000 of liabilities, subject to policy terms and conditions. Cover applies to all AJSBA sanctioned events, activities & meetings.

#### **IMPORTANT NOTES**

Cover Subject to Policy Wording

The above is a brief summary of cover provided. Copies of the policy wording, terms and conditions are retained by the AJSBA or available from Austbrokers City State Insurance Brokers.

Participation Exclusion

Liability incurred between Riders, i.e. Rider-to-Rider Liability, is not covered under the AJSBA's Public Liability policy. This includes both personal injury and damage to craft.

Should members require cover whilst participating in events, please contact Arthur Hatzinikolis at Austbrokers SPT on 1800 778 792.

SPT can provide participants with a Jet Ski policy, which extends to include racing and participation in organized events.
