President's Report (Justin Belczowski)

The President noted a successful year for the AJSBA with the return of a national tour (the first since 2001). Justin thanked Darren Williams, Ross Moore, Tessa Phipps and all other volunteers who carried the load of the responsibilities and contributed towards the success of the tour. It built further on our positive relationship with manufacturers and has received great feedback from competitors.

In 2014 the #201 Perpetual Trophy in honour of Joey Scaturchio was introduced for the winner of the tour's Pro/Am Stock Runabout class. The AJSBA honours and appreciates this opportunity to foster a relationship with the Scaturchio family and welcome them back to racing.

After internal issues and no racing in the 2013-14 season, the AJSBA welcomes the new QPWC committee. This group already have their race calendar prepared and have submitted their first event sanction request. The club will begin with social models of racing to build competitor numbers



and interest in the region. QLD remains a region of great potential due to the numbers of PWC owners and lack of waterways limitations.

Darren Williams noted Justin's exceptional leadership throughout the tour process, seconded by Ben Fuller.

Treasurer's Report (Darren Williams)

An unknown income was received in this financial year, ear-marked as overdue funds from QPWC but only verbal confirmation available.

Club affiliation fees were received from JSW, NSWPWC and NQPWC.

In terms of the 2014 national tour, the AJSBA took on the commercial risk and costs of Round 4. Additional expenses were incurred supporting Round 3 in Redcliffe, QLD.

Tour sponsorship funds are still owing from Jettribe and Yamaha.

Insurance fees are less than previous years due to a change in broker used.

Areas to minimise expenses related to the national tour were recognised as-

- Posters. This cost is already relatively small but further research could be done.
- Staging for the final round.
- Travel and accommodation for event officials.
- Catering for presentations.
- Sponsorship.
- Trophies and novelty cheques.

Justin Belczowski noted that he thought this was a small loss considering the achievements of the previous 12 months.

biggest club membership historically. In 2014 various professional competitors travelled there for the tour round. They had the biggest open ski class and the only naturally aspirated class of the tour. There was no stock runabout class at the Perth location but the club aims to build and have held a Spark class in their 2013-14 season. JSW are committed to Perth as the Round 1 and Round 2 location of the national tour. Burswood on Swan is a premier location for racing. Discussion needs to take place regarding the King of the River/Duke of the Swan race model and whether it can be incorporated as a supercourse heat of the tour or if it must be an independent event. Support from JSW in regards to transport for interstate riders must be increased. The JSW AGM is being held on 28 th June 2014 to finalise discussions.	and Darren Williams

National Classes

Classes to be raced in the 2015 national tour and suggested for state club seasons:

- Pro/Am GP Ski
- Pro/Am Open Runabout
- Pro/Am Ski Lites
- Pro/Am Stock Runabout (for specific rider classifications only)
- Amateur Showroom Stock
 Guidelines are available and discussed regarding this new class, 'bolt on' modifications only, these also contribute to safety. This class has
 the support from dealers and contingency schemes have been
 suggested. This class is aimed at encouraging novice riders to become
 involved in racing.

Due to the lack of competitors and complications aligning the AJSBA classification of the Naturally Aspirated class with the IJSBA classification, this class will not be included in the 2015 national tour.

Rider Classifications

Darren Williams suggested that the AJSBA align their rider classifications with the IJSBA model. This allows riders to progress through classifications and has international backing and the ability to translate to international racing. A template application is to be created to a classification change request. This model will be adopted for all licences moving forward and revised forms will be issued and announced at the beginning of August.

AJSBA to adopt similar profile to the AWA as PWC representative body

The AJSBA expressed a desire to move forward with this idea as they recognise the huge recreational PWC market but it was noted that the association is lacking the resources to commit to what they believe to be a full-time role. The association does have contacts in each state to assist with the facilitation of this concept as well as documents and logos but a volunteer/s is needed to drive the project.

It was suggested that a sub-committee be created, potentially led by Peter Hunter if he is willing, to focus on recreational riders and education. This sub-

committee would be made up of a representative from each state club. Darren Williams nominated himself as a representative of JSW and Ben Fuller nominated himself as a representative of the NSWPWC. A representative from QPWC is to be recruited. Each state club is to be encouraged to hold an education Come Try Day per year.

The formation of this sub-committee is to be further discussed and finalised at the first AJSBA committee meeting in 2014.
